IMPORTANT INFORMATION ABOUT YOUR CHILDS LUNCH ACCOUNT.

Lunch Prices effective for the 2021 – 2022 school year.

Each child will have their own account – no more family accounts.

- 1) You are able to monitor each of your child's accounts using the online service; it is also free to setup and to monitor.
 - a. You can set up an email alert to let you know when your child has reached a certain amount.
 - b. You can monitor what your child is purchasing on a daily basis.
- 2) You are able to deposit monies into your child's account using the online system.
- 3) Convenience fee – There is a small fee to place money online into your child's account. If you have multiple children, you will only be charged one fee if you place money on each account in one transaction. This fee will be added to the amount you deposit. This fee covers the service charge that the credit card company charges for the service.
- 4) The web site is SECURE. They will not use or sell your information to anyone.

What are you waiting for, go to www.myschoolbucks.com and click "register for a free account". Select Texas & continue, then select Academy ISD & continue. From there follow the simple steps and you will be on your way to making sure your child has the opportunity of a fresh hot meal every day. You will need to add your child once your account is set up. You will need their student ID number for this. If you do not have your child's student ID number you may request it from the site or call their campus and we would be happy to provide that to you.
